General Information

REMESO, Institute for Research on Migration, Ethnicity and Society, pursues interdisciplinary research, education and knowledge dissemination on transnational migration, ethnic diversity and citizenship.

The institute has since its start also developed:

- a platform for international visiting researchers
- a graduate school in Migration, Ethnicity, and Society
- a PhD program in Ethnic and Migration Studies
- academic networks and cooperation
- stakeholder collaboration and policy evaluation
- migration- and ethnicity perspectives for education programmes at LiU
- quantitative and qualitative databases related to on-going research
- a vital seminar and workshop series
- a number of international conferences

REMESO receives substantial faculty funding support for the development and consolidation of ethnic and migration studies as a priority

research area at Linköping University. Longitudinal financial support from the Swedish Research Council for Health, Working Life and Welfare (FORTE, previously FAS) is targeted at building a research centre of international excellence focused on issues of labour market restructuring, migration and social inclusion in the context of contemporary globalisation, changing ethnic relations and frameworks of citizenship in both contemporary and historical perspectives. The institute attracts considerable external funding for research as well as from other academic research councils. Its research program gathers around 40 researchers from different disciplines and research traditions, which facilitates the development of an innovative interdisciplinary approach to ethnic and migration studies. REMESO hosts international guest professors and post-doctoral scholars for shorter or longer periods as well as PhD and Master students, who follow courses offered by the REMESO Graduate School.

The present report offers a review of the Institute's activities and development during 2012 and 2013.

Letter from the Director

REMESO has successfully passed its five years birthday. The two years of our work covered by this 2012–13 biannual report, has been an important time of consolidation, as well as inventive advance concerning research, as well as education and stakeholder oriented activities.

Two major international academic and stakeholder conferences during 2012 and 2013, together with numerous international workshops and seminars, have contributed to a consolidation of REMESO's position as a leading Nordic centre of excellence in its field. Applications to major Swedish research councils have materi-

alised in a high overall success rate with respect to both the number of project grants awarded and a substantial increase in medium-term external funding. The new projects, described in detail in this report, are in line with REMESO's target-setting mid-term evaluation (2011). These research projects follow up its intention to combine a deepened long-term enquiry into the themes of the institute's five research streams with the development of new theoretical angles and empirical-analytical perspectives. "Swedish Genes" crosses the Rubicon between the social and cultural sciences and medical and natural sciences. "Swedish pensioners in Spain" devel-

ops an original approach to south-north migration, domestic labour, and the restructuring of public services of advanced welfare states. “Strategies and Structures” places Swedish studies on “Ethnic Entrepreneurship” on the frontline of international research. Projects focusing on the long-term effects of Swedish school reforms, civil society and public sector “partnerships”, and on new “urban justice movements”, add new theoretical and empirical dimensions to REMESO’s long-term studies on social exclusion and inclusion in segregated cities and ethnically segmented urban labour markets. On the basis of a Swedish Research Links a Swedish-Turkish-Mexican research consortium initiates an investigation of migration and development and the role of civil society in global governance.

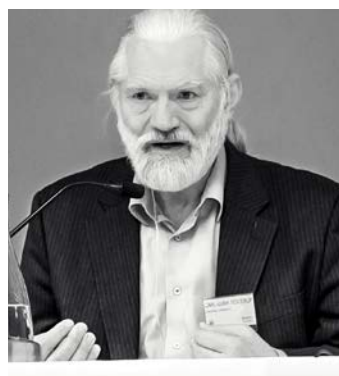
REMESO remains an institute for research and postgraduate studies, responsible to the Philosophical Faculty and the vice chancellor, with a continuing aim of acting as a node for research and education on migration, ethnicity and society across Linköping University. From 2012, the research institute has been located together with undergraduate educational programmes within an administrative sub-unit belonging to the multidisciplinary Department of Social and Welfare studies (the REMESO “sub-department” from 2013 headed by Magnus Dahlstedt). This has advanced conditions for the building of a unique centre of learning in cultural and social studies, facilitating a mainstreaming of ethnic relations and international migration throughout teaching in post-graduate studies and in BA and MA programmes. While existing BA and MA programmes are taught in Swedish, REMESO scholars are currently developing a new international Masters programme on ethnic and migration studies, synchronised with perspectives and courses of the REMESO graduate school. Through the efforts of the sub-department’s studies director, Anita Andersson, the teaching of REMESO scholars is also facilitated within other educational programmes of the Department of Social and Welfare Studies.

Thus 2012 and 2013 have been marked by further development of the institute and its programme of research through the work of a resourceful academic and administrative staff. But

current changes also point to the need for a diversified recruitment of new academic staff. This represents a challenge seen in both a short and middle range perspective. Alireza Behtoui and Susanne Urban, both central for the institute’s development of quantitatively oriented studies, are moving their main activities to, respectively, the University Centre of Södertörn and Uppsala University. During the coming two years most of REMESO’s current PhD students will defend their theses. During the period from 2015 to 2018 three out of currently four REMESO’s professors are likely to terminate their work within the institute on a regular, full-time basis in relation to their age. Another important challenge is to extend the institute’s highly successful efforts in securing continuous external funding from Swedish research councils with stepped up initiatives to apply for grants from international funds for research and teaching.

I am fully confident that we will be successful in meeting these and other challenges ahead; and I am very pleased to see a range important new initiatives, currently taken by REMESO colleagues, receiving wholehearted support from the Vice Chancellors Office, the Philosophical Faculty and the Department of Social and Welfare Studies, as well as valuable guidance through the REMESO board and our international advisers.

I wish you all good luck in your work; and on behalf of all colleagues I thank Erik Berggren for his efforts to compile this report’s documentation of our common work during the preceding two years.

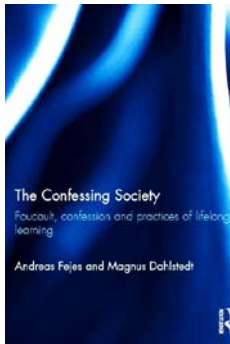

Highlights

■ Publications

REMESO's scientific output is marked by a high level and wide variety of channels spanning from the most prestigious international peer reviewed scientific journals and publishers to a prolific engagement in current debate and popular scientific activity. The institute's publications also display the strong interdisciplinary character of its research and education. Here are few examples of last year's output. For a near complete list of publications see further below in this report.



Magnus Dahlstedt, Associate Professor at REMESO and his colleague Andreas Fejes, Professor and chair of adult education research at Linköping university, in their latest book, *The Confessing Society*, take a critical look at the ideology underpinning ideals that promote “lifelong learning” in school and work and dissect its relation to governance strategies in education and on the labour market. The authors focus on how people are increasingly encouraged to verbalise and disclose their “true” inner self to others, whether on TV-shows, in newspapers, in family life or together with friends. *The Confessing Society* takes a critical stance towards the modern relentless will to disclose the self and argues that society has become a confessing society. Drawing on Foucault's later work on confession and governmentality, this book carefully analyses how confession operates within practices of lifelong learning as a way to shape activated and

“responsible” citizens and provides examples of how it might be possible to traverse the confessional truth of the present time.

Stefan Jonsson, Professor at REMESO published a new book at Columbia University Press: *Crowds and Democracy: The Idea and Image of the Masses from Revolution to Fascism*.

Between 1918 and 1933, ‘the masses’ became a decisive preoccupation of European culture, fuelling modernist movements in art, literature, architecture, theatre, and cinema, as well as the rise of communism, fascism, and experiments in radical democracy.

Crowds and Democracy revisits the notion of ‘the masses’ and identifies some uncertainty in the literature about its role and status historically, and in the representation of ‘the mass’ in inter-war Europe. Often, studies of the masses from this time was motivated by and even locked to, the rise of fascism. But Jonsson demonstrates the ambivalence and diversity that reflects the 1920s and 1930s representations of the masses and the people of Germany and Austria.

Jonsson's book provides an analysis of society that connects aesthetic representation with political narrative, and then reveals how ‘the masses’ cannot be reduced to a mass psychological phenomenon, fascism or totalitarian tendencies, but simply stands in the centre, then as now, in the issue of democracy and how we represent the people of the community, both politically and aesthetically.

This volume is the second instalment in Stefan Jonsson's epic study of the crowd and the mass in modern Europe, building on his work in *A Brief History of the Masses*, which focused on monumental artworks produced in 1789, 1889, and 1989.



A contemporary reflection, not without bearing to Stefan Jonsson's work, was published by **Carl-Ulrik Schierup, Aleksandra Ålund and Lisa Kings**: "Reading the Stockholm Riots" – in *Race & Class* (2014 55:1). This text which looked at the Stockholm riots and youth movements challenging urban degradation and reclaiming citizenship and democracy, also took on the task to deconstruct some simplified notions about "masses," democracy and popular discontent, and in particular, in relation to perceptions of discontent in multi-ethnic urban areas.

The article examines the 2013 riots in Stockholm in the context of other urban rebellions across disadvantaged metropolitan neighbourhoods in the North-Atlantic region over the past three decades of neoliberal transformation.

Naturally the riots in Stockholm and elsewhere are a focal point for media, which thus become a co-creator of the event and the discourses around it. Sometimes the mediatized event takes another route as in the case of an article published by Associate Professor **Susanne Urban** a sociologist at REMESO. Her piece in the *Nordic Journal of Migration Research*, 3 (2) created quite a buzz in Swedish Media, as it apparently touched some key issues in the policy debate. In 'Restaurant work-experience as stepping stone into the rest of labour market: Entries to and exits from the restaurant sector among young people of immigrant backgrounds in Sweden' she questioned some widely believed assumptions that have guided recent policy in regard to entries to the labour market. The current government had some prestige invested in a tax cut for restaurants with the ambition to stimulate employment in the

sector. This drew a lot of attention from Swedish media and columnists that both delivered criticism and praise for her work.

Also addressing labour market conditions in Sweden is Professor **Charles Woolfson** who has, among a prolific output of articles, published two specifically on weaknesses in the Swedish model that has surfaced in recent developments. For example with Judy Fudge and Christer Thörnqvist (2013) he has published "Migrant precarity and future challenges to labour standards in Sweden" in *Economic and Industrial Democracy*, Vol. 35. The article identifies key weaknesses in the Swedish model of industrial relations and suggests that recent changes to the Swedish labour migration regime in 2008 may have detrimental impacts on labour standards, particularly in low-skill low-wage occupations creating new spaces for migrant precariousness within the context of a formerly well-regulated Swedish labour market model.

With Petra Herzfeld Olsson and Christer Thörnqvist (2012) he has published 'Forced Labour and Migrant Berry Pickers in Sweden' in *International Journal of Comparative Labour Law and Industrial Relations*. Vol. 28, No. 2. In it the authors address how groups of migrant berry pickers arriving annually in Sweden from both Asia and the newer European Union Member States have been subject to exploitation over the years. The problem appears to persist in spite of public and international concern and successive regulatory reforms. An examination of this problem from

a forced labour perspective suggests inadequate implementation and application of international norms in Swedish law, as well as deficiencies in the application of criminal-law and in regulatory oversight.

On an equally politically hot topic as some of the above, but maybe stirring even more sentiments, not least among political commentators, is the research on *Eurafrica* and the Colonial Roots of European Integration which Associate Professor **Peo Hansen** and Professor **Stefan Jonsson** has pursued in a set of scientific articles and also in Swedish media, and, which will be presented in a forthcoming book in 2014 (London: Bloomsbury). In the *Mediterranean Quarterly* (4:2013) they wrote about *Eurafrica* and the neglected link between colonialism, decolonization and the emergence of the European Union. The article, “A Statue to Nasser? *Eurafrica*, the Colonial Roots of European Integration, and the 2012 Nobel Peace Prize” show how the birth of the Union was not entirely steered by altruistic motives, but that central rationales were also driven by economic, neocolonial and geopolitical interests. These interests were directly addressed and part of the arguments for a union, at the time when the creation of a European union was discussed among central European leaders.

■ Conferences and Workshops

Arranging conferences and workshops in addition to weekly seminars for researchers and guests, is a recurring task. These last years there have been several events and below are the more major ones.

‘Labour Rights as Human Rights?’

In May 30 – June 1, a number of internationally wellknown researchers and activists came to Norrköping for the conference ‘Labour Rights as Human Rights? – Labour Market Restructuring and the Role of Civil Society in Global Governance’, organised by REMESO and INMD (International Network for Migration and Development), under the auspices of UNESCO-MOST. Keynote lectures were given by Saskia Sassen, Columbia University, Ronaldo Munck, Dublin City University, Guy Standing, University of Bath, Stephen Castles, University of Sydney and Raul Delgado Wise.

The background to this conference is the migration the follow from major political and economic changes in Eastern Europe, the growth of industrial and service economies such as China and India and increasing conflict- and climate driven refugee movements. With mobility of capital, restructuring of economies and flexibilisation of labour markets, this has set off unprecedented informalisation and precarisation of work with re-enforced ethnic, racial and gender segmentations, as well as deteriorating social rights.

Due to these developments major international organisations have sought to establish global normative frameworks for human and labour rights and fair rules for cross-border movement. Among them is the UN initiative for ‘fair globalization’. Another is the ILO’s ‘decent work agenda’. In addition, a range of civil society movements are engaged in redefining issues of migration and global governance in the nexus of human rights, social rights and labour rights.

This global scenario of structural change was the context for the ‘**Labour Rights as Human Rights?**’ conference in Norrköping, Sweden. Scientifically responsible for the conference was Professor Carl-Ulrik Schierup, REMESO. It housed beside debates and keynotes in plenum, also two two-day workshops, each divided into three sessions in which international researchers and civil society activists discussed human rights and labour rights.

Austerity in the Baltic States

On a related topic, yet with a geographically more specific focus, the Baltic states, REMESO was in May 2013 hosting the workshop “Contradictions of Austerity: Migration and The Socio-Economic Costs of the Neoliberal Baltic Model”. The event was co-organised by Arunas Juska, visiting researcher at REMESO otherwise at University of East Carolina (US), Jeffrey Sommers, University of Wisconsin-Milwaukee (US) and Charles Woolfson, REMESO.

The workshop started with Arunas Juska presenting his and Charles Woolfson’s paper “The bifurcation of the Lithuanian labour market under the impact of crisis: The creation of a new

austeriat” in which they argue that the austerity policies adopted in the Baltic states since early 2008 have accelerated the formation of ‘dual labour markets’ typical for post-communist countries.

With the example of Lithuania, they showed that key factors behind the current crisis must be seen as reflective of the underdevelopment of the country’s economy, as well as its dependent and peripheral position within the European Union and the global economy. More specifically, harsh austerity policies combined with the effects of previous massive EU transfers have accelerated the fragmentation of the labour market that, in turn, have contributed to the further social and political fragmentation of the wider society – resulting into “two Lithuanias” – a process of societal disarticulation that is producing a new generation of “winners” and “losers”.

Jeffrey Sommers followed up with “‘Always Ready’: Austerity & Social (In)Security. Latvia’s Neoliberal Devolution”. In this paper he discusses how the Baltic states during the economic and financial crisis from 2008 onwards, were subject to some of the harshest austerity measures ever attempted by democratically elected governments. The boldness and sweep of these measures has led to worldwide interest and indeed, admiration among ruling circles, both in Europe and the US who contemplate introducing the same.

Sommers asked what really exists behind the hagiographic accounts of the Baltic model of austerity management. And he answered that it is a myth that says that radical austerity measures can be carried through at low demographic and political cost and with manageable levels of social disruption. These contributions and a number of others by leading scholars comprise an edited volume for Routledge (2014).

“Austere Histories: Social Exclusion and the Erasure of Colonial Memories in European Societies”

Austerity was also the central topic and object of inquiry of an international Symposium in November 2013, organised by REMESO, and held at Arbetets Museum, Norrköping. The symposium asked the question if the current politics of austerity also propel a turn toward austerity, not only in social and economic policy, but also in theories and practices of historiography? I.e. are there grounds to speak of an austere historiography that enforce conformity on the meaning of Europe, past and present?

The background to the symposium was the increasingly austere European political regimes, seen in budget cuts, management of the labor market and restrictions of welfare systems, as well as in new regimes of migration and citizenship. Changes that create new forms of social inclusion and exclusion that are justified through a reactivation of differences of race, class and gender, that, in turn, serve as rationalizations of new forms of labor extraction and the growth of a new under-class or “precariat”.

If the current austere politics also entail an austere historiography it would help to explain the proliferation of assertively heroic and homogeneous stories about the past of nations, regions, institutions and religions that are being retold, reinvented, and re-launched. In brief, history (including public debate on history and history education) is again becoming either “nationalistic” or “cosmopolitan” – but cosmopolitan in a way that tend to celebrate

the achievements of Europe and posit the West as a model of universality, humanism and perhaps also of the human as such.



Among the sacrifices of this tendency are multiculturalism, postcolonial memories, and minority discourses of all kinds. What is lost is the very complexity and contradictoriness of Europe and the West. Especially, colonial and postcolonial memories are evicted from their recently claimed habitats in the European past, and again placed at the outskirts, far beyond the limit of the Western world.

Stefan Jonsson took the initiative and led the work of organising the symposium.

■ New Research Projects and Funding

School reform, urban justice movements, inclusion in suburb areas and a critical look at genetics research

REMESO is always active in developing new research projects and during the last couple of years this has met a positive response with the research councils as the outcome of funding applications have been successful, creating chances for developing new roads for REMESO's research, as well as deepening established perspectives.

Susanne Urban receives 6,37 million SEK from the Swedish Research Council for a project on Swedish School reforms: "School choice reforms implementation and long term consequences for individuals' social mobility. School choice reforms implementation and long term consequences for individuals' social mobility."

With Magnus Dahlstedt, REMESO, and Anders Trumberg, Örebro University, she will analyse the content and long term consequences of reforms in the area of school choices, the actual choices made and generally the effect on individuals' social mobility in Sweden, with a special focus on Örebro, Norrköping and Linköping. Hitherto, research on school choices has been focusing on bigger urban areas, and they tend to regard segregation and its consequences as a big city phenomenon.

Lisa Kings and Aleksandra Ålund, REMESO has received a grant from FORMAS of 3,9 million SEK for research on "Urban justice movements: Youth activism in civil society dialogue"

After the violent youth rebellions in Swedish suburbs during later years, a plurality of new dialogue oriented activist groups have emerged, profiled as youth urban justice movements (YUJM). They address issues of segregation, racism and welfare transformation in Swedish cities. The project will explore expressions of agency; claims, network building and knowledge production with focus on cooperation and dialogue between YUJM and the wider civil society in two different cities, Gothenburg and Stockholm.

Anna Bredström, REMESO, has been awarded a large research grant on 5,4 million SEK from the Swedish Research Council for the project "Swedish Genes? Ancestry and Ethnicity in Human Genetics Research". She will be working with PhD Shai Mulinari, University of Lund, to explore how ethnic, national and racial categories are defined and made use of in genetics research, with a particular focus on research that either is produced in a Swedish academic context, or focuses empirically on Swedes/non-Swedes. The background is the upsurge of human genetics research during the last decades. Often it makes use of ethnic, national and racial categories. A central tenet in much of this research suggests that there is a general correspondence between genetic and evolutionary divergences between populations, and some argue that there are distinct genetic structures in different populations and that 'genes mirror geography' within different regions.

By comparing three fields of human genetics research – 1) population genetics; 2) pharmacogenomics; and 3) genomic epidemiological studies possible tensions between basic science and clinically oriented research will be examined, and possible implications for clinical practice and pharmaceutical commerce will be discussed.

Key research questions for the project include the following: What methodological difficulties do human genetics research meet that uses ethnic, national and racial categories and how are these resolved?; What are the translational implications of using ethnic and racial categories in a largely international field?; Which ethical and political questions arise?; What are the broader implications of the development in human genetics research for contemporary theories of race and ethnicity?

REMESO has also been awarded a Swedish Research Links grant of 747,000 SEK from The Swedish Research Council for the collaborative international project “Migration and development. What space for civil society in global governance? (MIGLINK)”. The project is a Swedish-Mexican-Turkish Research Links consortium of researchers at the universities of Linköping, Zacatecas and Ankara. **REMESO participants are Carl-Ulrik Schierup, Branka Likić-Brborić, Aleksandra Ålund and Anders Neergaard.**

MIGLINK aims to examine the development of an incipient global governance framework for migration with a focus on the role of civil society. The Global Forum for Migration and Development (GFMD), initiated at the UN global dialogue High Level Dialogue on Migration and Development in 2006, is the most inclusive state-led forum between governments on developing policies for international migration. Since its inception, so-called ‘Civil Society Days’ were organized as an integrated part of the GFMD process. On the background of a review of the UN High Level Dialogue and previous GFMD meetings – with particular emphasis on GFMD in Mexico 2010 – the consortium will follow preparation, agenda setting, debates and outcomes of upcoming GFMD meetings in Sweden, 2014 and Turkey, 2015. It will contextualise them in historical and geographical perspective,

aiming to identify the role of civil society in global policy making through the GFMD.

Magnus Dahlstedt Associate Professor at REMESO, received 4,55 million SEK from the Swedish Research Council for a project that will investigate collaboration and inclusion in multi-ethnic suburbs and urban areas. A lot of attention has been given to recent riots in multi-ethnic urban areas, in France, England and lately also in Sweden.

Internationally these events have been linked to changes in the welfare state and social conditions, and to social grievances among immigrants and ethnic minorities. However, in Swedish research, the link between institutional changes and discontent among youth is somewhat neglected. The aim of this project is to investigate different measures to improve living conditions for youth in marginalised, multi-ethnic urban areas. An important issue is to what extent there is emerging collaborations, both between schools and other institutions and between schools, institutions and other actors within civil society. A special emphasis is placed on cooperation between schools, social service and police.

Associate Professors Martin Klinthäll, Susanne Urban and Zoran Slavnic from REMESO have received a large research grant together with Hans Landström, Tobias Schölin, Craig Mitchell

at the Sten K Johnson Centre for Entrepreneurship, Lunds universitet from Marianne and Marcus Wallenbergs Foundation. They have received 5,347,000 SEK for three years for the project “Strategies and Structures. A multi-disciplinary study of the preconditions for entrepreneurship among immigrants in Sweden”. The project has also been awarded support of 2,4 million from Handelsbanken, Sweden.

The project analyses how changes in policies and regulations affect conditions and opportunities for small business development in different industries over time, and how self-employed persons act in response to changes in opportunity structures. They will study strategies of growth and survival within specific industries and markets, but also transitions of self-employment across industries and types of markets. The project systematically applies and develops instruments from recent international research on ethnic minority businesses (EMB). Theory in the field is developed through the integration of entrepreneurship theory and new theoretical contributions from EMB research.

■ Education

3 million to the REMESO Graduate School

The REMESO Graduate School in Migration, Ethnicity and Society secured funding in late 2012 for the coming 3–4 years through a grant from FORTE, The Swedish Council for Working Life and Social Research.

The Director Peo Hansen and the coordinator Tunde Puskas take joy in this confirmation of the schools quality. Positive is that the school now has a more long-term stability and that the new grant gives opportunity to develop new courses and national and international collaborations. Among other things, there are collaborations under planning with Karolinska Institutet and Stockholm University in a course on migration and health. The Graduate School is also part of a planned consortium of four European and four American universities. The theme is “Changing Patterns of Nationalism, Ethnocentrism and Immigrant Accommodation in the US and Europe”.

The Graduate School has been critical for REMESO's international profile. Since its start in 2009 15 courses have been given for Masters and PhD students from all over the world. Over 250 students have taken courses and they come from all together 32 different countries. Besides REMESO's own faculty, the Graduate School has been engaging a large group of guest lecturers from all over Europe.

International Master Programme: Ethnicity, Migration and Globalization

During 2012 and 2013 a work has begun to develop an “International Master programme in ethnicity, migration and globalization. The work has been led by a joint team at REMESO.

The first students are planned to be enrolled in 2016. The programme is a two-year, full-time study programme that will prepare students for further postgraduate studies, teaching and research in the interdisciplinary field of Ethnic and Migration Studies with special reference to globalization and social transformation. Moreover, the programme qualifies the students to integrate perspectives concerning migration and ethnicity in higher education across disciplines and faculties as well as for professional work in organisations, media, communication, politics and knowledge production. The programme offers students knowledge of theories and methodologies in Ethnic and Migration Studies with special reference to globalization and social transformation as well as academic skills to use this knowledge in analysis and innovative intervention in research as well as in governmental and non-governmental organisations.

The programme would add an important element which would further develop and complete the supply of educational tracks at REMESO and cater a clear and well-defined demand coming from international students for a Masters programme in the field, as well as from Swedish student who seek an internationally oriented education and specialisation within ethnicity and migration.

The program in Social and Cultural analysis rated to be of ‘High Quality’ in evaluation

The educational programmes for bachelor and master degree meet standards for “High Quality” in latest evaluation by the Swedish Higher Education Authority.

At REMESO a programme has recently been evaluated – Social- and Cultural Analysis (BA) and (MA) – and both meet the standards for “high quality”. The evaluators see the program as meeting the goals in giving students tools to pursue complex analysis of social issues, organisations and authorities with a variety of scientific methods. They also highlight how students at these programs attain knowledge and awareness of cutting-edge scientific discussions and can apply these fruitfully and critically discuss choices of research and investigation methods.

The program director, Mathias Martinsson, and a group of teachers, Eva Bolander, Birgitta Plymoth and Kenneth Petersson, have been working intensively with the evaluation report last spring to supply the external team of evaluators with material.

“It is especially heartening that evaluators have recognized and confirmed the special ambition of the programs to give students tools for pursuing independent, critical and scientifically astute analyses of varied projects, phenomena and activities in society. They highlight the continuity between the bachelor program and the master, in the broadening and deepening of analytic skills and critical application of different scientific approaches”, Mathias Martinsson concludes.

The institute's ongoing projects are organized in five thematic research streams that are described below. Stream 1: Migration, Welfare and the Political Economy of Labour Market Segmentation

This research stream includes studies on migration, changing work organisation and ethnic segmentation in private and public sectors of the economy. It relates the political economy of international migration and changing ethnic relations to the study of transformed welfare re-

gimes and labour market regulation, and to the incremental influence of supra-national frameworks of governance. Central research areas are corporate restructuring and the informalisation of labour, recruitment and employment strategies, institutional discrimination, the impact of social capital, local and transnational networks and career strategies of migrants and ethnic minorities.

Stream 2: Globalisation and the Reconstitution of Normative and Legal Frameworks

This stream addresses policy challenges brought about by the globalisation, EU enlargement, governance of migration and related flexibilisation of labour markets and the consequential implications for labour standards. It examines regulatory and normative discourses of migration management at one level, and the empirical and policy outcomes of processes of globalization on the European labour market on the other. The stream pays particular attention to new peripheries of Europe, both in the former communist countries now within the EU and those on its doorstep. Of particular interest is the development of inclusive agendas that promote labour rights and collective forms of representation at workplace level thus securing decent work.

Stream 3: Post-National Strategies for Growth, Inclusion and Diversity

The focus of this stream is the analysis of a wide range of strategies for institutional innovation in the Swedish and European context, contingent on changing policies on work and social welfare. The stream examines novel strategies for development, inclusion and diversity, from the post-national to the national, regional and local level, initiated in policy areas, such as education and work, entrepreneurship, regional and urban development. It examines networked and deliberative forms of governance based on partnerships between actors across sector divisions, including public sector institutions, business, trade unions, employer agencies, NGOs and civil society.

Stream 4: Citizenship and Ethnic Relations: Social, Cultural and Historical Perspectives

The stream is organized around issues of citizenship and ethnic relations, which resonate into two major areas of research; one dealing with politics and policy, and how the relation between individual and state is transformed through the institution of citizenship; the other dealing with ethnicity, culture and politics of belonging, and how the relation between individual and community is transformed through the ways in which the individual is addressed as embodying a specific ethnic, national, racial, sexual or gendered identity. Citizenship and ethnic relations are seen as instances of social formation and collective identification and hence as parts of the most enduring fabrics of human history

Stream 5: Migration, Public Service and Health

Research within this stream includes the study of migration and ethnic relations in welfare institutions with particular focus on health and education. Central questions are how public services are organized and distributed to an ethnically diverse population, the implementation of social rights and provisions and how clients and customers are shaped materially and discursively in these processes. The impact of racialization and social exclusion on migrants' health and education is also crucial for this stream. The studies adopt an intersectional approach and

examine how ethnicity, gender and other categories of difference are mutually constitutive and thus expand the field, previously mainly studied through the lens of gender research.

Databases and Surveys

REMESO have developed a database on register based data mainly based on Longitudinal integration database for health insurance and labour market studies (LISA by Swedish acronym) <http://www.scb.se/LISA/> provided by Statistics Sweden complemented with e.g., geographic information on residence, schools and workplaces.

The database contains annual individual data on the total population in Sweden over 16 years of age. Variables include e.g., incomes, education, work and geographic data annually from 1990. Data on companies has also been added in order connect the economies of corporations and businesses to employers and employees. The database is updated every second year. It also includes detailed data for the analysis of labour market transformation and welfare, including possibilities to aggregate data on regions, local communities, industries and different immigrant groups.

A number of surveys have been performed by REMESO researchers. In the project: “Social capital and the educational achievement of young people” run by Alireza Behtoui and Anders Neergaard, data were collected during spring term 2012. A survey was conducted by distributing a questionnaire in 65 classes of ninth graders in 30 schools from distinctively different areas in Stockholm, Linköping and Norrköping. A total of 1268 pupils participated. The survey conducted questions about the economic, cultural and social capital of respondents.

REMESO is also a partner in the newly completed dataset LNU-UFB (*Levnadsnivåundersökningen av utlandsfödda och deras barn*), composed by the Stockholm University Linnaeus Centre for Integration Studies (SULCIS), led by Professor Carl le Grand. The dataset is the most extensive qualitative data compilation about immigrants and their descendants in Sweden.

Education: Graduate and Undergraduate

Graduate Level

REMESO's International **Graduate School in Migration, Ethnicity and Society**, is integrated with REMESO's PhD programme in Ethnic and Migration Studies. The Graduate School courses primarily cater to PhD students, but are also open for MA students. The curriculum consists of 10 different courses, covering a broad range of topics and approaches to the field of ethnic and migration studies. The school's funding base runs until 2016 thanks to a generous grant from the Swedish Research Council for Health, Working Life and Welfare (FORTE).

The Graduate School sorts under the REMESO Steering Committee for Education. The School is managed by a director, associate professor Peo Hansen, a coordinator, associate professor Branka Likić-Brborić and an assistant, PhD student Julia Willén.

The school also has an International Advisory Board, Professors: Raul Delgado Wise (University of Zacatecas, Mexico), Ursula Apitzsch (University of Frankfurt), Jan Rath (University of Amsterdam) and Ronaldo Munck (Dublin City University).

The REMESO Graduate School forms a key part of the internationalization of education and research at REMESO; and as such it serves as a platform for exchange with international scholars and students from all over the world.

The aim of this network is to develop and carry through a research program focussing on changing trade union strategies in Turkey, South Africa and Sweden, as they face irregular (“undocumented”) migration and increasing precarity of labour connected with restructuring and informalisation of economies and labour markets. The project is premised on a view of migration as an increasingly important global phenomenon, but structured by particular regional economic asymmetries and migration sub-systems: processes that place post-apartheid South Africa as an attractive economy and migration hub in the Southern African region; Turkey on the one hand towards the states of former Eastern bloc and on the other as a stop for migrants and refugees from the south often

with plans for continuing their migration; and, Sweden as a highly regulated welfare state and high immigration hub at the Northern post of European Union, close to the Baltic states and Poland, new member states of the European Union.

Financial Report

Revenues for the development of the integrated research programme at the Institute for Research on Migration, Ethnicity and Society (REMESO) stems from three primary sources:

- Yearly long term funding through the Faculty of Arts and Sciences. For the period 2008–17 this includes substantial yearly counterfinancing to the institute's FORTE long term centre of excellence programme from the Vice Chancellor;
- A long term grant from the Swedish Research Council for Health, Working Life and Welfare aimed at the development of REMESO centre of excellence focused on globalisation, labour market restructuring and social inclusion;
- Funding from external sources (mainly Swedish) research councils for the carrying out of a number mid-range research projects within the REMESO research programme.

The budget as a whole is stable concerning incoming funding as well as spending. While the total financing by Linköping university has decreased by close to one million SEK compared to 2012, the financing from external sources has increased marginally and the total spending marginally decreased.

Revenues for teaching at first and second-courses and study programmes consist of funding for education within the Faculty of Arts and Sciences and the Faculty of Educational Science (the Social and Cultural Analysis programme, the Master's programme in Social and Welfare Studies, and courses in Society and Culture in Education within the Teacher Education). The budget concerning teaching at first and second-courses and study programmes for the period 2012–2013 is stable, accommodating a buffer regarding continual professional development of staff, course development and fluctuations in both the number of students and study performance in the coming years.
