New Research/Communication Projects

Anders Neergard has with several colleagues at REMESO received a communication grant from the Swedish research Council (VR) for a project that aims at circulating knowledge in new ways: "Communication alliance in the field of Migration and Integration: New forms of knowledge circulation for public education and societal dialogue". The project will invite, writers, artists or journalistsas guests to REMESO during a couple of months to participate in discussions, partake in research and then help us disseminate knowledge and perspectives on issues of migration and integration in their channels of communication. The ambition is to create a stronger discussion and dissemination of research based knowledge so to impact public understanding and political deliberation.

Karin Krifors, Remeso, have together with Hege Høyer Leivestad at Oslo University received funding from FORMAS, the Swedish research council for sustainable development, for the project: "Unpacking the Logistics Town: how local communities are reshaped in the wake of Amazon's European warehouse expansion". During four years they will study how three cities in Spain, Sweden and England undergo changes and how handle the logistification of economy, work and land after Amazon has established warehouse business to there.

Talks

Peo Hansen was in January invited as Keynote speaker at the conference "Migration and Integration: Critical Perspectives in Conversation" at Stockholm School of Economics. The other keynotes were Adrian Favell (Univ College Cork) and Leila Hadj Abdou (European University Institute). Hansen spoke about his recent book: *A modern Migration theory: an alternative economic approach to failed EU policy* (Agenda Publishing, 2021)

Claudia Tazreiter, professor at REMESO, has given several talks during the Autumn. At Umeå University, Sociology Department she talked in October about "Digital resistance to contemporary bordering practices and a 'politics of becoming'". In November she gave a talk at Uppsala University "Haunting as an afterlife of state violence. The case of refugee detention on Manus Island, Papua New Guinea" and in December she took to Germany and The Kulturwissenschaftliches Institut at University Duisburg-Essen and spoke as Guest Lecturer in the Colloquium series on "Art, activism and archives from the perspective of exile and displacement"

Courses for Graduate Students

The Graduate School in Migration and Integration is jointly run by REMESO and the University of Gothenburg's Department of Sociology and Centre on Global Migration. The school is financed by a grant from the Swedish Research Council and provides Swedish and international PhD students with the opportunity to participate in advanced teaching and research training in the areas of migration and integration. Professor Peo Hansen is the Director of the Graduate School.

Since these research fields suffer from weak representation within PhD education, the school serves as a national and international hub for PhD teaching, research-training and networking.

Euroafrica launched in France

Peo Hansen and Stefan Jonsson, professors at REMESO, were recently in France to present their book *Eurafrique: Aux origines coloniales de l'Union Européenne* at University of Paris-8, and at University of Lille. The English version, Eurafrica: *The Untold History of European Integration and Colonialism* (2014) has received wide acclaim. The French edition from 2022 is translated by Claire Habart and has been reviewed in Le Monde, Le Dévoir, Mediapart, among others. Cultures of Rejection in the COVID-Crisis

"Cultures of Rejection" is a REMESO-led project that investigates the social and cultural conditions in which right-wing authoritarian movements thrive. It conducts research along the transnational space created by migration movements in 2015: in Serbia, Croatia, Austria, Germany and Sweden. A volume is published which summarises findings regarding mobilisations against COVID-19 measures (lockdowns, face masks, vaccinations) and on the relationship between these mobilisations and the media responses to them.
